E. JPA BUSINESS

E1. Selection of Vendor for Property Appraisal Services Contract

SCORE has not performed property appraisals of members' locations since 2006. It is important to conduct property appraisals every three to five years in order to properly place property coverage at adequate limits for each location. These services would not only provide members with a current replacement cost estimate of the structures and contents but would also provide accurate data to be used in developing the property insurance premiums. A \$60,000 budget allocation has been included and approved for this purpose in the FY 2012/2012 Budget and staff was directed to obtain proposals from multiple vendors as to determine the cost for the project. In response to the RFP issued by SCORE in July 2012, three vendors submitted proposals for Property Appraisal Services with costs ranging from \$48,500 to \$70,000. The proposing vendors were as follows: American Appraisal with a bid of \$70,000, AssetWorks with a bid of \$48,500 and CBiz with a bid of \$57,500. After reviewing all three proposals, the Executive Committee Board members decided to award the contract to AssetWorks Inc. as they offered the best value out of the three proposing companies. AssetWorks not only had the lowest dollar cost per structure but they also met or exceeded all the requirements outlined in the Request for Proposals.

A motion was made to appoint AssetWorks Inc. as the Property Appraisal Services provider for SCORE's Property Appraisal project.
